

DEFINITIVE LIST OF ACCEPTED AND EXCLUDED PROJECTS FOR THE EVALUATION PHASE - THIRD CALL "INNOVA INVEST PROGRAMME"

In accordance with Article 16.5 of Order ECM/71/2025, of January 16, which establishes the regulatory bases for the granting of subsidies under the 'Innova Invest' Program of ICEX Spain Trade and Investments, E.P.E., and announces the first call within the framework of the European Regional Development Funds, once the application submission period has ended will be published:

- 1.- Definitive List of Projects Admitted for Evaluation.
- 2.- Definitive List of Projects Excluded from Evaluation, including the reasons for exclusion.

The accepted applications will undergo an evaluation process, for which purpose the Instructing Body will forward them to the Evaluation Committee. After the process of evaluating the applications, the Instructing Body, based on the dossier and the report from the Evaluation Committee according to the assessment criteria established for this call, will announce, justified and ordered according to their score:

- a) A proposal for a provisional resolution on the applications benefiting from a subsidy up to the maximum subsidy amount that can be distributed.
- b) A proposal for a provisional resolution on all the applications which, in compliance with the administrative and technical conditions established in the present call to acquire the condition of beneficiaries, cannot be considered beneficiaries due to having reached the maximum authorized amount of credit fixed in this call.
- c) A proposal for a provisional resolution on the applications in the evaluation that have not reached the minimum score of 50 points or the minimum threshold of 10 points in the evaluation criteria a) "Business capacity to execute its investments in Spain".
