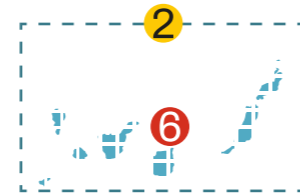

### General incentive:

- **Tax rebate up to 30%** of first €1m + 25% in excess deduction base
- **Minimum expenses** in Spain: Live action €1m / Animation €200k
- **Eligible expenses:** Creative staff with residence in Spain or European Economic Area; expenses derived from the use of technical industries and other suppliers
- **Cap per project:** €20m film / €10m per episode / Special conditions for animation and VFX services apply
- **Total cost of production** cannot be less than €2m
- **Partner with a production company** with tax residence in Spain

### Special regional incentives:

#### Canary Islands:

- Tax rebate up to 54% of first €1m + 45% in excess deduction base
- Cap per project: €36m film / €18m per episode
- Partner with a production company with tax residence in Canary Islands region

#### Basque Country:

- Tax credit up to 60%
- Partner with a production company with tax residence in Basque Country region

#### Navarre:

- Tax credit up to 50%
- Cap per project: €5m deduction base.
- 1 week shooting in Navarre
- Partner with a production company with tax residence in Navarre region
